SECTION 2 — HAZARDS IDENTIFICATION

Hazard class: Flammable solids (Category 2). Flammable solid (H228). Keep away from heat, sparks, open flames, and hot surfaces. No smoking (P210).

Hazard class: Acute toxicity, oral (Category 4). Harmful if swallowed (H302). Do not eat, drink or smoke when using this product (P270).

Hazard class: Skin and serious eye damage, corrosion or irritation (Category 2, 2A). Causes skin and serious eye irritation (H315+H319).

SECTION 4 — FIRST AID MEASURES

If exposed or concerned: Get medical advice or attention (P308+P313).

If inhaled: Remove victim to fresh air and keep at rest in a position comfortable for breathing (P304+P340).

SECTION 5 — FIRE FIGHTING MEASURES

SECTION 6 — ACCIDENTAL RELEASE MEASURES

SECTION 7 — HANDLING AND STORAGE

Flinn Suggested Chemical Storage Pattern: Organic #4. Store with ethers, ketones, and halogenated hydrocarbons.

Store in a dedicated flammables cabinet. If a flammables cabinet is not available, store in Flinn Saf-Stor™ can.

Keep container tightly closed (P233). Ground or bond container and receiving equipment (P240). Use only in a hood or well-ventilated area (P271).
