SECTION 2 — HAZARDS IDENTIFICATION

SECTION 4 — FIRST AID MEASURES

Wipe cap and bottle threads and immediately reseal container after dispensing to preserve the expanding property. Keep container tightly closed (P233). Use only in a hood or well-ventilated area (P271).
