Signal Word(s): Warning

Hazard Statement(s): Flammable liquid and vapor. Causes serious eye irritation. May cause drowsiness or dizziness.

Precautionary Statement(s): Keep away from heat/sparks/open flames/hot surfaces. No smoking. Keep container tightly closed. Avoid breathing dust/fume/gas/mist/vapors/spray. Wash hands thoroughly after handling. Use only outdoors or in a well-ventilated area. Wear protective gloves/eye protection/face protection. SECTION 4: FIRST AID MEASURES

First Aid Measures

Inhalation: Not a normal route of exposure. If breathing is difficult, remove victim to fresh air and keep at rest in a position comfortable for breathing. Call a POISON CENTER/doctor/physician if you feel unwell.

Eye Contact: In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. If easy to do, remove contact lenses, if worn. If irritation persists, get medical attention.

Inhalation: Vapors may cause drowsiness and dizziness. May cause respiratory tract irritation.
